- Represented Nuseed, a Sacramento, California-based global agriculture innovator enabling the transformation of select crops into renewable and traceable sources of lower-carbon energy and plant-based nutrition, in connection with a “private” free and clear sale transaction under Bankruptcy Code Section 363 with Yield10 Bioscience, Inc. (OTCMKTS: YTENO). Yield10 Bioscience, Inc. is a Massachusetts-headquartered agricultural bioscience company that is using its differentiated trait gene discovery platform to develop improved Camelina varieties for the production of proprietary seed products. Yield10 filed for bankruptcy protection in December 2024, simultaneously seeking approval for a sale to Nuseed of substantially all of Yield10's assets, including intellectual property and seed materials. The court approved the sale the first week of January 2025 and the sale closed the following week. *In re: Yield10 Bioscience, Inc.*, 24-12752-MFW (Delaware).
