OVERVIEW

Jonathan Cohen is a partner and a member of the Insurance Recovery and Counseling practice group. His practice focuses on representing policyholders in obtaining insurance coverage in complex, multiparty disputes involving product liability, product recalls, cyber events, and supply chain issues.

Jonathan also has worked at the forefront of issues involving the overlap of insurance and bankruptcy, recovering billions of dollars through representations of debtors, claimant committees, a future claimant's representative, and post-bankruptcy trusts.
